**FOOTPATH 418036, MAIN STREET TO FORESHORE, RAVENGLASS, MUNCASTER

This order is made by the Lake District National Park Authority (“the Authority”) by virtue of an agreement between the Authority and Cumberland Council whereby the Council delegated to the Authority its powers of surveying and modification under the provisions of the Wildlife and Countryside Act 1981 (“the Act”) in respect of the administrative area of the Lake District National Park.

The order is made pursuant to the provisions of Section 53 (2) (b) of the Act because it appears to the Authority that the County of Cumbria Definitive Map and Statement require modification in consequence of the occurrence of an event specified in Section 53(3)(c)(iii), namely the discovery by the Authority of evidence which (when considered with all other relevant evidence available to them) shows that any other particulars contained in the map and statement require modification.

The Authority has consulted with every local authority whose area includes the land to which the order relates. The Authority hereby orders that:

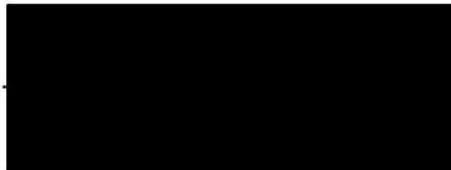
- 1 For the purposes of this order the relevant date shall be 17 November 2025.
- 2 The County of Cumbria Definitive Map and Statement shall be modified as described in the Schedule and shown on the plan attached to the order.

- 3 This order shall take effect on the date it is confirmed and may be cited as the Lake District National Park Authority Definitive Map Modification Order 2026, Footpath 418036, Main Street to Foreshore, Ravenglass, Muncaster Parish, and is dated 22 January 2026.

Marked with a bold black line and shown A-B	From Main Street at Point A (SD 0840 9636) west-northwesterly through garden of Wingrove Cottage for around 40 metres to the foreshore at Point B (SD 0836 9637).

Right of way to be added as indicated on plan	Description of route of right of way to be added
Marked with a bold dashed line and shown C-D	<p>From Main Street at Point C (SD 0841 9637) generally west-northwesterly for around 40 metres alongside Spindrifft, over steps and onto the foreshore to Point D (SD 0837 9638).</p> <p>Width:</p> <ul style="list-style-type: none"> • Varying between 1.5 and 1 metres wide from Main Street (SD 0841 9637) to steps (SD 0839 9638); • 0.9 metres wide (0.75 metres usable width due to handrail) over steps (SD 0839 9638); • 0.8 metres wide on concrete path from steps to foreshore (SD 0839 9638); • 1.8 metres wide over foreshore (SD 0839 9638 to SD 0837 9638)

Description	In Ravenglass, from Main Street, west-northwesterly alongside Spindrifft for 40 metres on to the foreshore. Width – varying between 1.5 and 1 metres from Main Street (SD 0841 9637) to steps (SD 0839 9638), then 0.9 metres over steps (SD 0839 9638), then 0.8 metres on concrete path from steps to foreshore (SD 0839 9638) and then 1.8 metres over foreshore (SD 0839 9638 to SD 0837 9638).

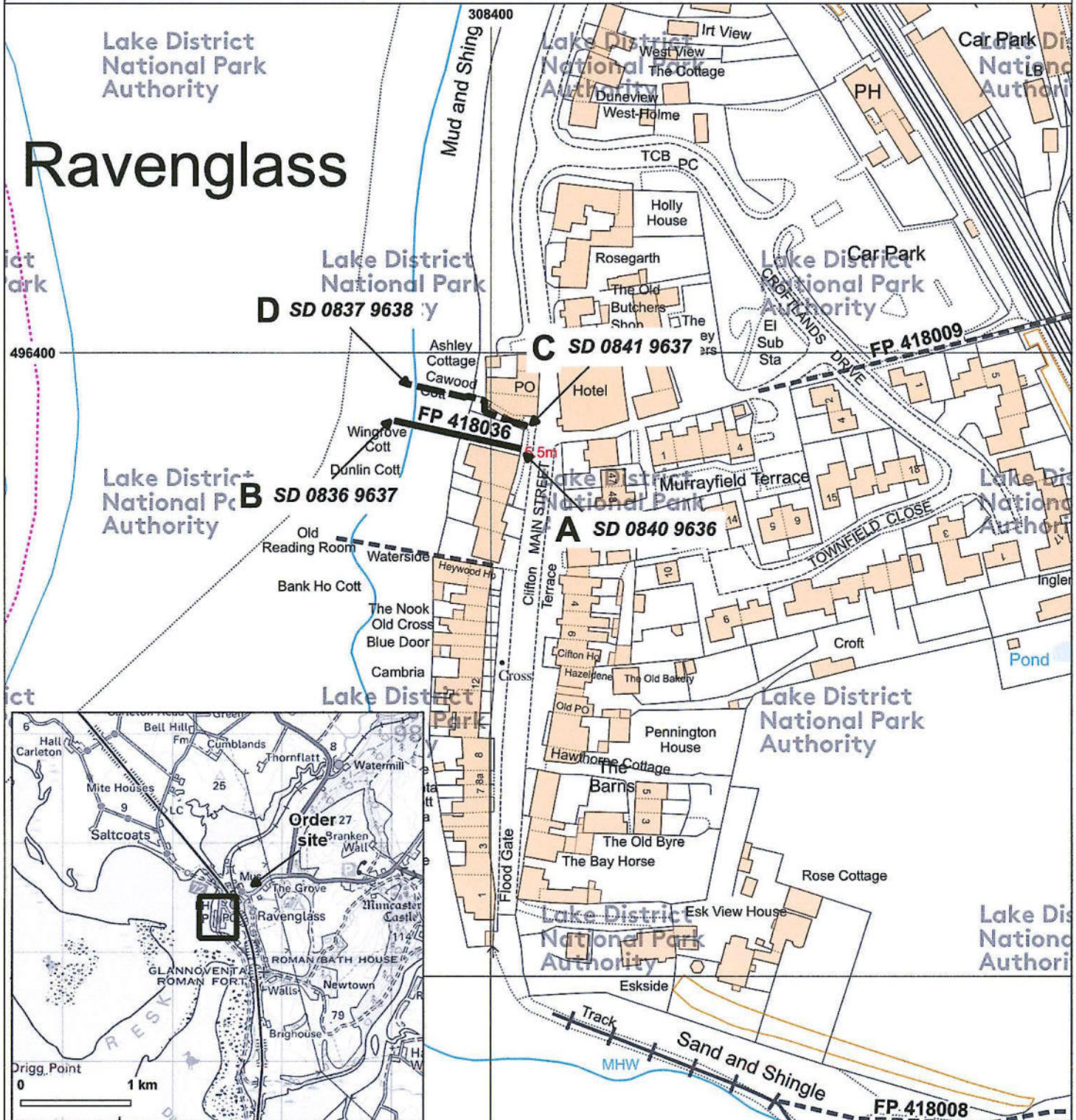
