PUBLIC RIGHTS OF WAY AFFECTED BY WEST COAST PYLON RE-CABLING

TEMPORARY PROHIBITION OF TRAFFIC ORDER 2026

NOTICE IS GIVEN that under Section 14(1) of the Road Traffic Regulation Act 1984, the Lake District National Park Authority has made an order dated 2 April 2026. The effect of the order is to prohibit all public traffic for all purposes from proceeding over various footpaths and bridleways in the parishes of Bootle, Drigg and Carleton, Muncaster, Waberthwaite and Whicham Parish, to enable works to install new power lines.

The notice and plans showing the route concerned may be inspected during normal office or opening hours at the National Park Authority, Wayfaring House, Murley Moss, Oxenholme Road, Kendal, LA9 7RL; at Cumberland Council Customer Services, Market Hall, Whitehaven, CA28 7JG; and at Bootle Post Office, 4 Main Street, Bootle, LA19 5TF; and online at www.lakedistrict.gov.uk/rowclosures.

The order will take effect on 14 April 2026 and will continue in force for six months. The works will be completed in sections, and the order will only be in force over those paths affected by the works at any given time. Signage will be erected indicating when closures are in effect on individual paths. At all other times the paths will be accessible as normal. There are no suitable alternative routes when closures are in effect. If the works have not been completed during this period the order may be extended for a further period with the approval of the Secretary of State.

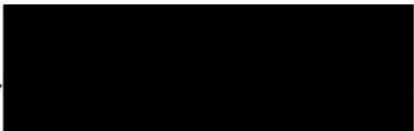
WHEREAS the Lake District National Park Authority (hereinafter referred to as "the Authority") being the Agent for Cumberland Council for the footpaths and bridleways specified in the schedule hereto attached, is satisfied that all public traffic on the said highways should be prohibited to enable works to install new power lines.

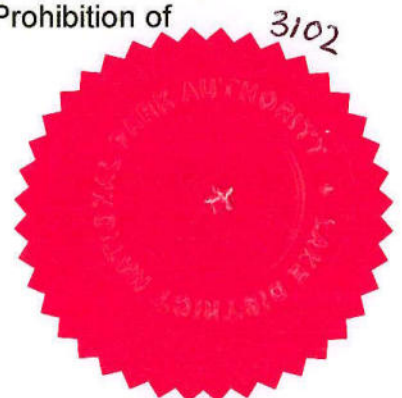
NOW THEREFORE the Authority in exercise of the powers under Section 14(1) of the Road Traffic Regulation Act 1984 (as amended) and all other powers enabling them in that behalf HEREBY MAKE the following order:

- 1 No public traffic shall proceed along those sections of the footpaths and bridleways between the Ordnance Survey grid references specified in the schedule below.
- 2 The Interpretation Act 1978 shall apply for the interpretation of this order as it applies for the interpretation of an Act of Parliament.
- 3 This order shall come into operation on 14 April 2026 and will continue in force for six months, or until the works have been completed, whichever is the earlier. The works will be completed in sections, and the order will only be in effect over those paths affected by the works at any given time. Signage will be erected indicating when the order is in effect on individual paths.
- 4 This order may be cited as the Lake District National Park Authority (Public Rights of Way Affected by West Coast Pylon Re-Cabling) Temporary Prohibition of Traffic Order 2026.

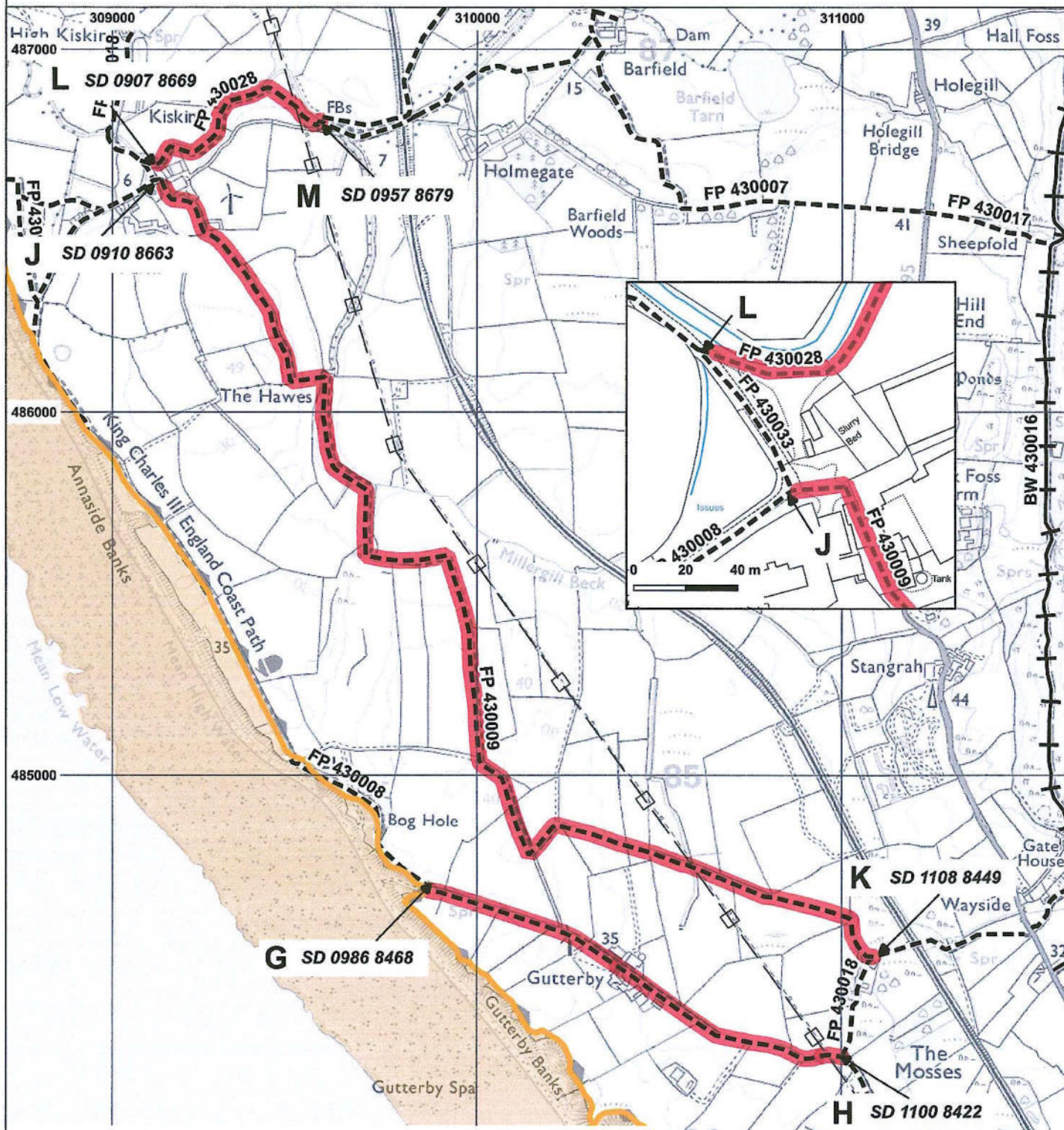

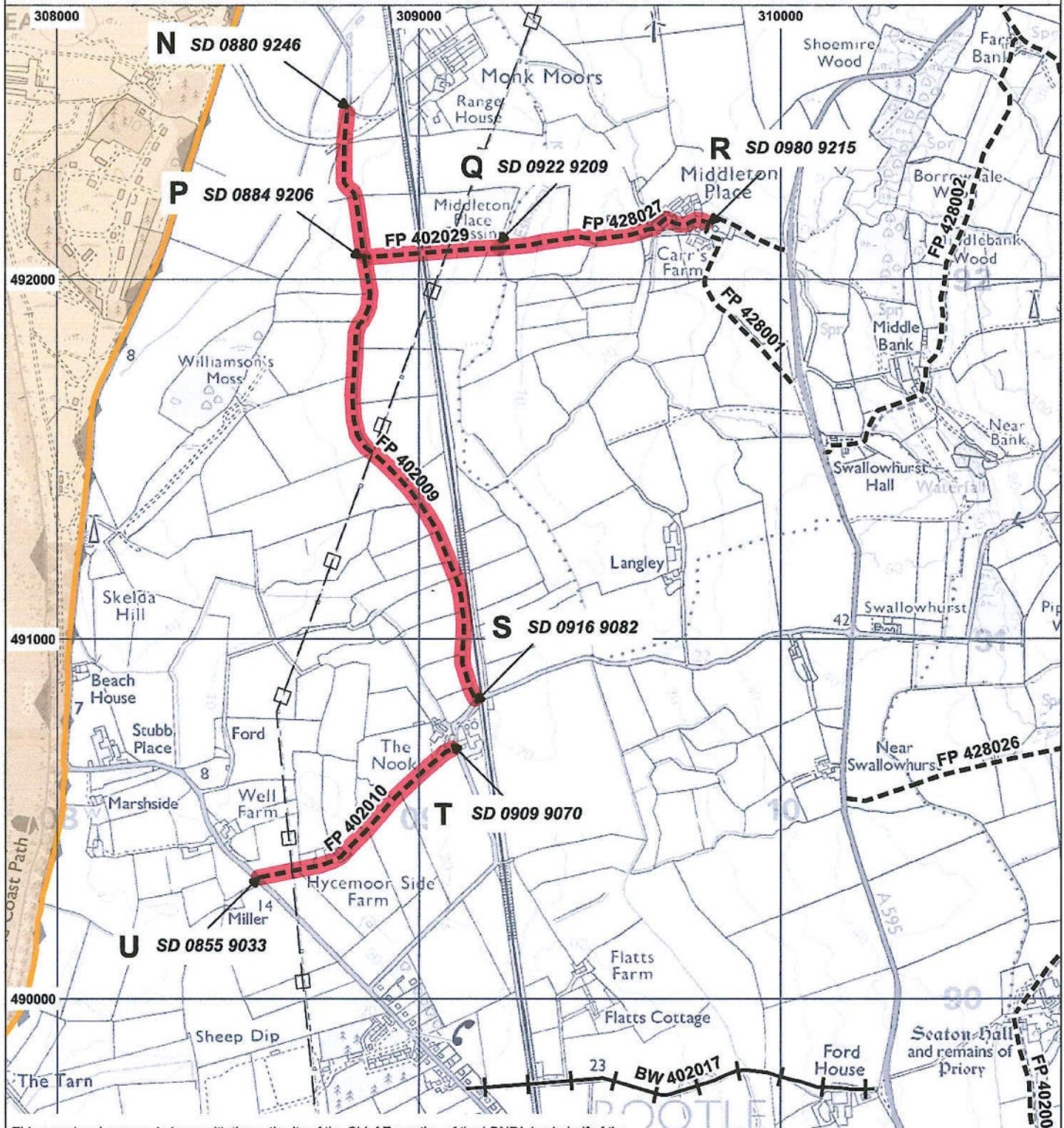

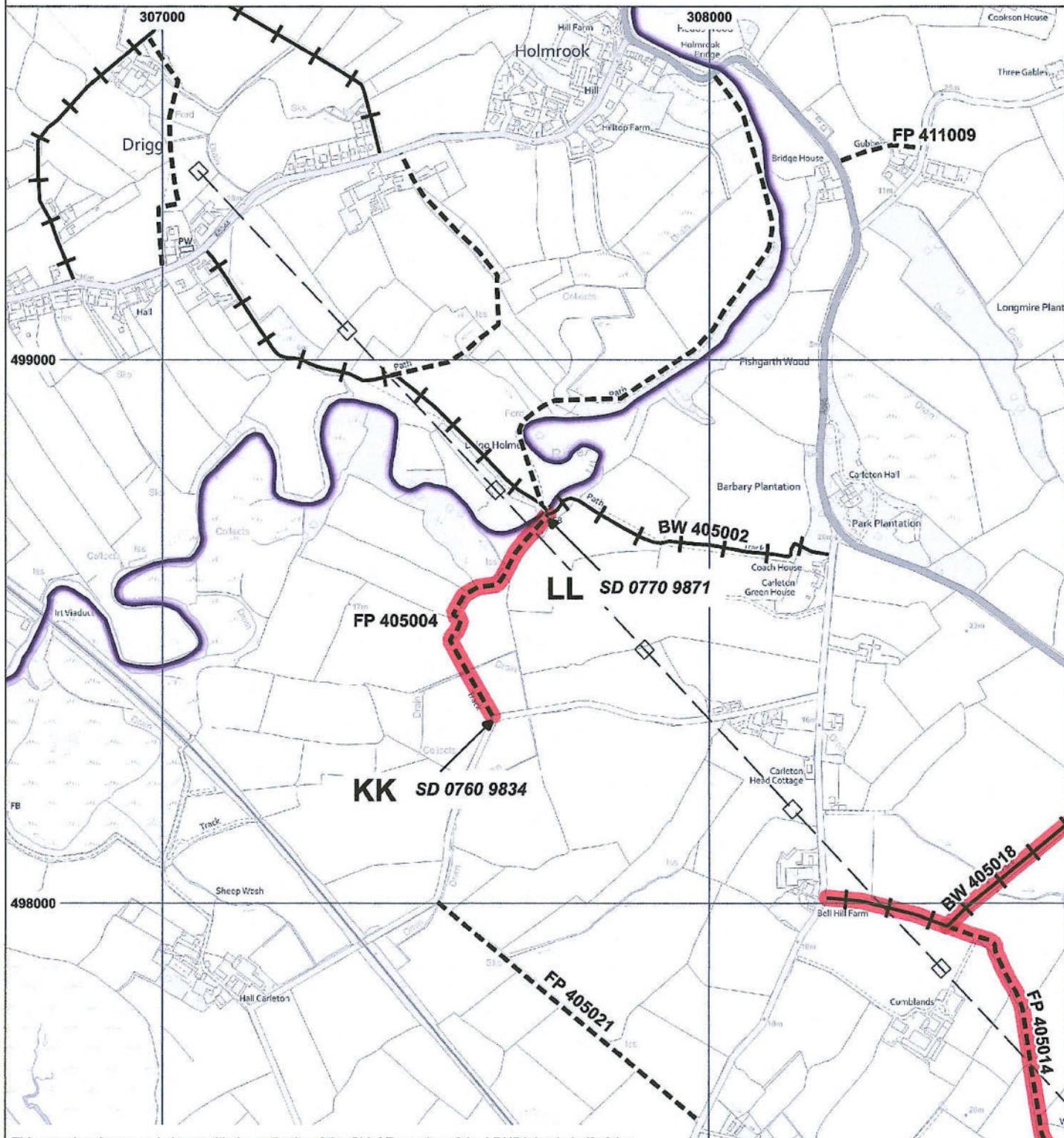
