

TOWN AND COUNTRY PLANNING GENERAL DEVELOPMENT ORDER 1973LAKE DISTRICT PLANNING BOARDWHEREAS

1. The Lake District Planning Board (hereinafter called "the Board") is the local planning authority for the area of the Lake District National Park.
2. The Board is satisfied that it is expedient that no development of the class specified in the Schedule hereto shall be carried out in the area hereinafter mentioned unless permission is granted on an application in that behalf.
3. The Board is acting under the powers conferred upon it by Article 4 of the Town and Country Planning General Development Order 1973 (hereinafter called "the Order").

NOW THEREFORE THE BOARD DIRECT that the permission granted by Article 3 of the Order shall not apply to development of the description specified in the Schedule hereto in the area of land shown edged red on the plan annexed hereto and situate in the Rural District of Cockermouth in the Lake District National Park at Hill Farm, Thackthwaite.

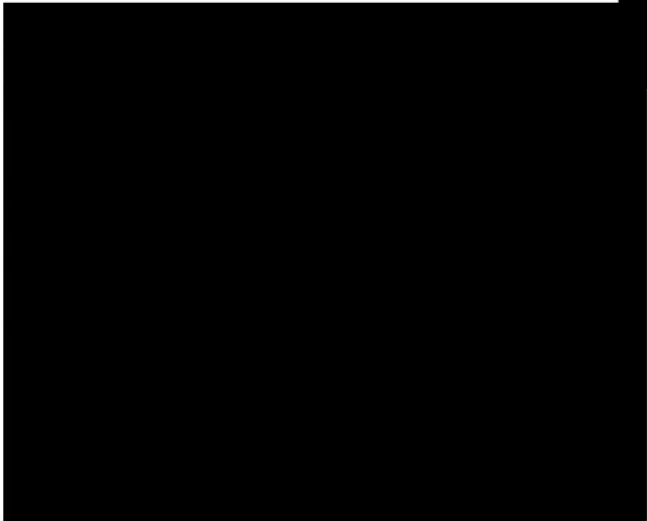
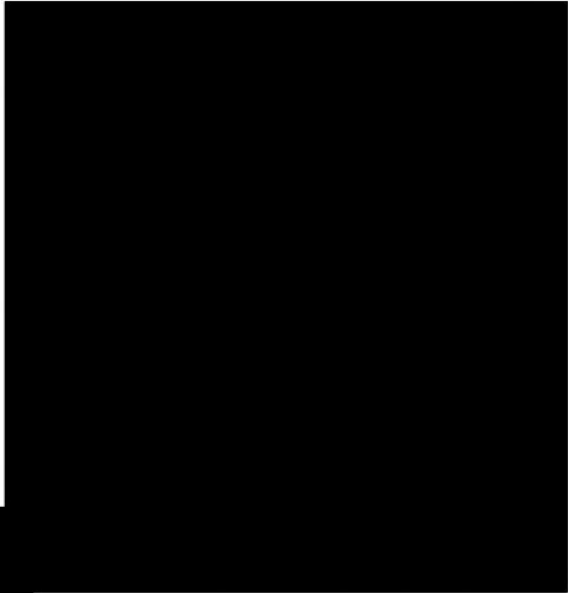
