TOWN AND COUNTRY PLANNING GENERAL DEVELOPMENT ORDER 1973

LAKE DISTRICT PLANNING BOARD

WHEREAS :

1. The Lake District Planning Board (hereinafter called "the Board") is the local planning authority for the area of the Lake District National Park.
2. The Board is satisfied that it is expedient that development of the class specified in the Schedule hereto shall not be carried out in the area mentioned unless permission is granted on an application in that behalf.
3. The Board is acting under the powers conferred upon it by Article 4 of the Town and Country Planning General Development Order 1973 (hereinafter called "the Order").

NOW THEREFORE THE BOARD DIRECT that the permission granted by Article 3 of the Order shall not apply to development of the description specified in the Schedule hereto in the land shown edged red on the plan annexed hereto and situate in the Urban Districts of Lakes and Windermere in the Lake District National Park at Limefitt, near Troutbeck, Windermere, Westmorland.

IN WITNESS whereof the Lake District Planning Board has caused its Common Seal to be affixed this 26th day of October one thousand nine hundred and seventy three.

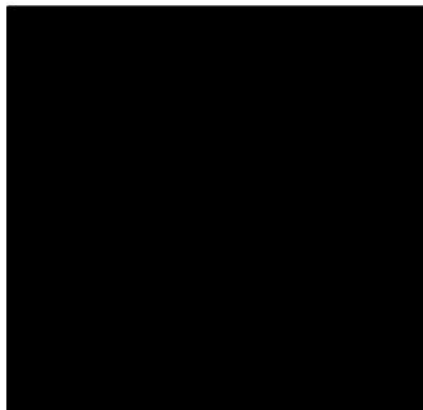
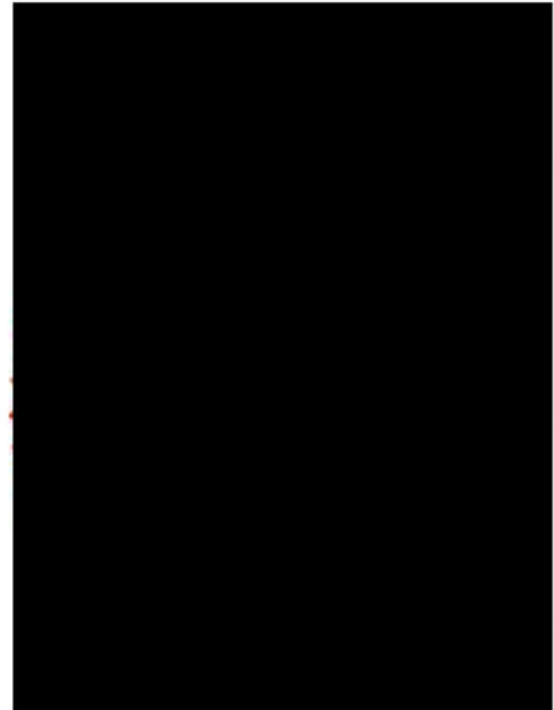

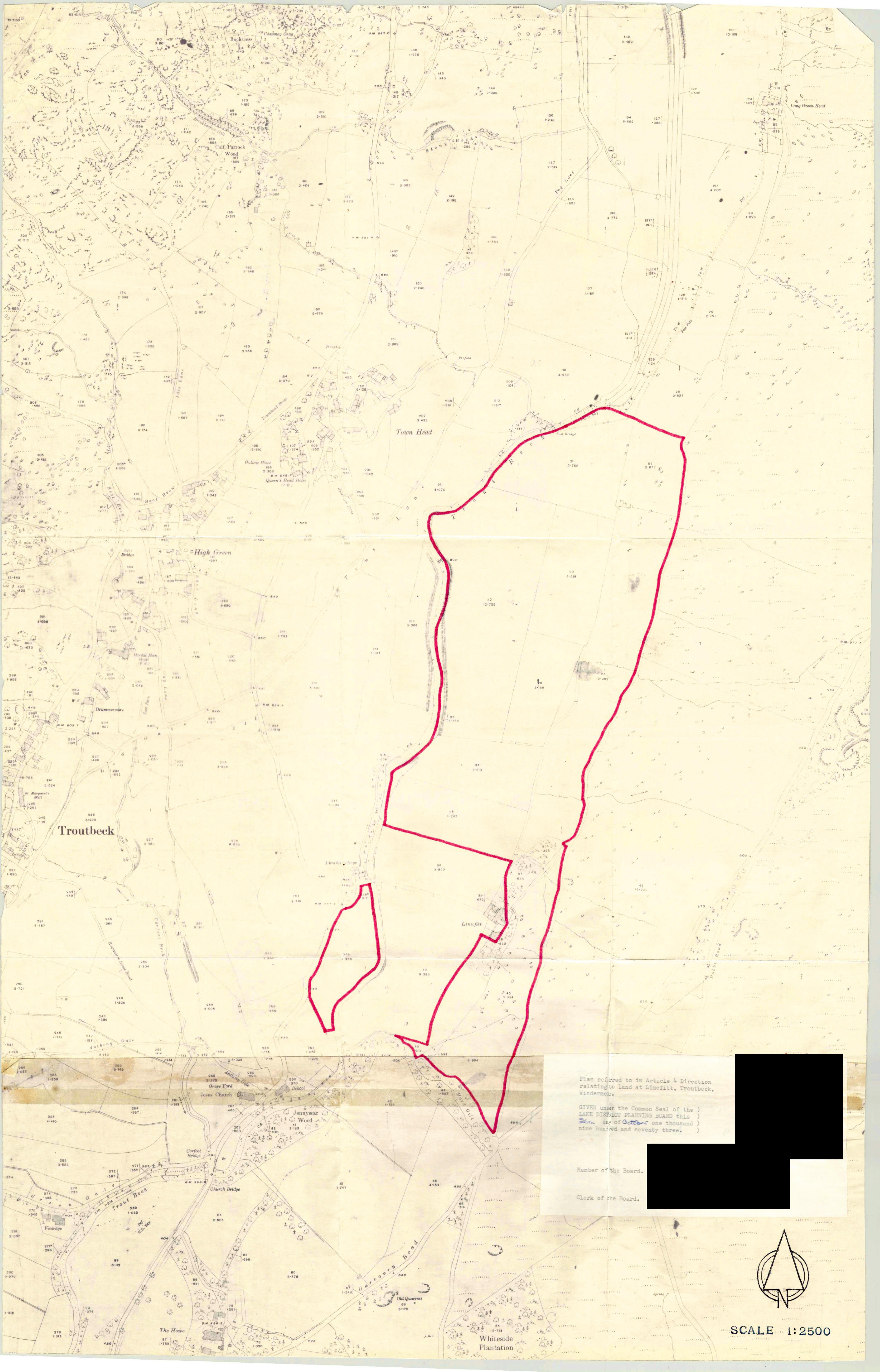

High Green

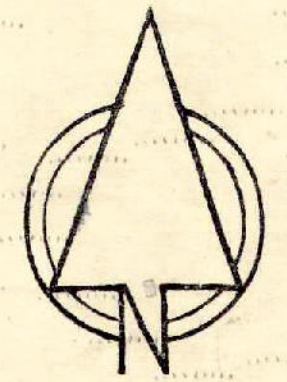
