TOWN AND COUNTRY PLANNING (GENERAL DEVELOPMENT) ORDER 1973 76 19 76

LAKE DISTRICT SPECIAL PLANNING BOARD

WHEREAS

1. The Lake District Special Planning Board (hereinafter called "the Board") is the Local Planning Authority for the area of the Lake District National Park
2. The Board is satisfied that it is expedient that development of the class specified in the Schedule hereto shall not be carried out in the area hereinafter mentioned unless permission is granted on an application in that behalf
3. The Board is acting under the powers conferred upon it by Article 4 of the Town and Country Planning (General Development) Order 1973^{as amended} (hereinafter called "the Order")

NOW THEREFOR THE BOARD DIRECT that the permission granted by Article 3 of the Order shall not apply to development of the description specified in the Schedule hereto in the area of land shown edged red on the plan annexed hereto and situate at The Old Sawmill Site, Portinscale, Near Keswick in the County of Cumbria in the Lake District National Park

SCHEDULE

CLASS OF DEVELOPMENT

Development within Class VI (1) of the First Schedule to the Order that is the carrying out on agricultural land having an area of more than one acre and comprised in an agricultural unit of building or engineering operations requisite for the use of that land for the purposes of agriculture (other than the placing on land of structures not designed for those purposes or the provision and alteration of dwellings).
