

TOWN AND COUNTRY PLANNING ACT 1971

TOWN AND COUNTRY PLANNING GENERAL DEVELOPMENT ORDER, 1977

LAKE DISTRICT SPECIAL PLANNING BOARD

WHEREAS:

1. The Lake District Special Planning Board (hereinafter called "the Board") is the local planning authority for the area of the Lake District National Park
2. The Board is satisfied that it is expedient that development of the class specified in the Schedule hereto shall not be carried out in the area mentioned unless permission is granted on an application in that behalf
3. It is the opinion of the Board that development of the class specified in the Schedule hereto if carried out without planning permission granted in that behalf would constitute a threat to the amenities of their area
4. The Board is acting under the powers conferred upon it by Article 4 of the Town and Country Planning General Development Order 1977 (hereinafter called "the Order").

NOW THEREFORE THE BOARD DIRECT that the permission granted by Article 3 of the Order shall not apply to development of the description specified in the Schedule hereto in the land shown edged red on the plan annexed hereto and situate in the District of Allerdale in the Lake District National Park at Fellside, Manesty, Nr. Keswick, Cumbria

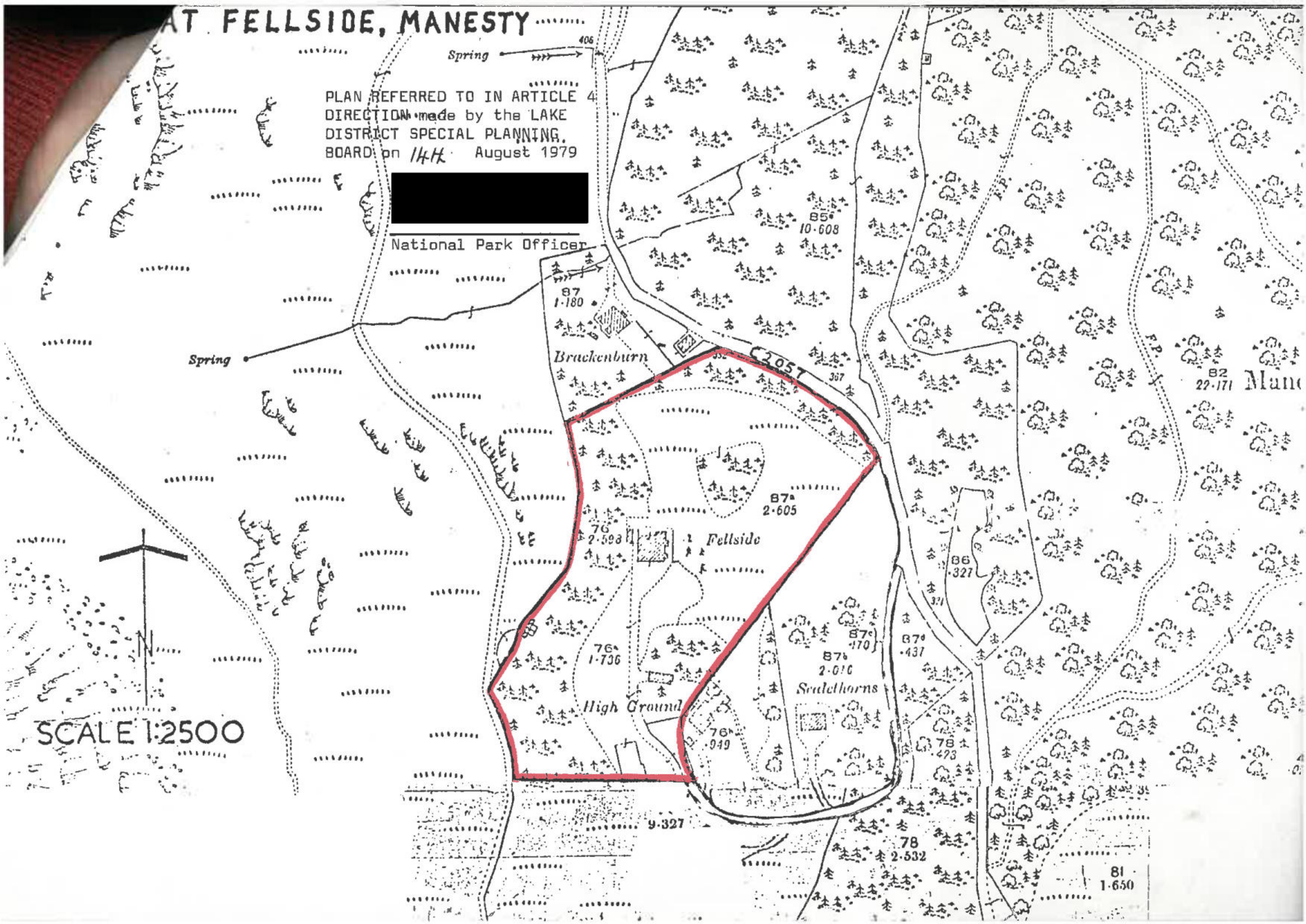
